Kansas Turnpike Authority**Request for Qualifications**

The Kansas Turnpike Authority (KTA) will release a request for qualifications (RFQ) on Thursday, July 25, 2019, for the Turner Diagonal and I-70 Interchange Design-Build Project. The I-70 and Turner Diagonal project is comprised of the Turner Diagonal interchange with I-70, the adjacent truck staging areas, and associated improvements along both I-70 and Turner Diagonal in Wyandotte County. The RFQ will be available at <http://www.drexeltech.com/>. Additionally, the RFQ can be picked up at Drexel Technologies on a CD, see the Drexel Technologies website for pricing. All purchases are non-refundable. Drexel Technologies can be contacted by phone at 913-371-4430 or electronically at <http://www.drexeltech.com/>. RFQ documents will be shipped only if the requesting party assumes responsibility for all related shipping charges. Corporate, certified, or cashier's checks shall be made payable to Drexel Technologies.

Prospective design-build teams must submit their Statement of Qualifications (SOQ) by 12:01 p.m. Friday,

August 16, 2019. The SOQ presents, in general terms, the design-build team's qualifications for the project. Design-build teams interested in submitting a SOQ should look for the RFQ on Thursday July 25 at the website above.

KTA will use a two-step process to select a design-build team. This RFQ to solicit SOQs is the first step KTA will use to evaluate which teams are most qualified to successfully deliver the project. KTA will shortlist up to four teams based on the SOQs and publish the shortlist on Friday, August 30, 2019. The second step, a request for proposals (RFP), will be released by KTA to shortlisted proposers in draft form on Monday, September 9, 2019 and in final form on Monday, October 7, 2019. KTA will score proposals and select a winning team on Friday, November 1, 2019.

The Turner Diagonal Project area is generally described as I-70 from the east facing ramps at 78th Street to 65th Street, Turner Diagonal from State Avenue to Riverview Avenue, and the trucking staging areas immediately west of 72nd Street. In December 2018, the United Government of Wyandotte County/Kansas City, Kansas (UG) was awarded a U.S. DOT BUILD Grant to partially fund the design and construction of the Turner Diagonal Project. The KTA, UG, and Kansas Department of Transportation have formed a partnership to deliver the Turner Diagonal Project via a design-build procurement. To satisfy the requirements set forth in the BUILD grant agreement, the proposed interchange concept shall be a diverging diamond and it must achieve substantial completion on or before October 16, 2020.

The Kansas Department of Transportation (KDOT) is seeking the services of a consulting firm for the KDOT guardrail set-aside program which is a program to remove/replace all blunt end guardrail terminals on the National Highway System (NHS) in Kansas. KDOT conducted a mainline NHS blunt end guardrail inventory and data collection was completed and reviewed in February 2019. The new inventory has approximately 1,639 remaining blunt end guardrail terminals and were separated in four tiers based upon traffic volumes and speed limits. This advertisement is for Tier 1 (22 sites) and Tier 2 (241 sites). This could be a multi-phase agreement. Phase I will include site visits and recommendations. Consul-

tant will develop the scope, schedule, and budget for each site in coordination with Road Design and Program Project Management. Phase I is to be completed by December 13, 2019. Phase II, if added, will include preparation of construction drawings and summary memos for construction letting. Additional phases may be added as needed as the program progresses.

Qualifications-Based Selection Process

Based on the qualifications submitted and other information available to KDOT, on or about August 16, 2019 KDOT will shortlist three to five firms and notify all firms submitting Letters of Interest of the names of the shortlisted firms by return email. Thereafter, KDOT will issue a Request for Proposal (RFP) to the shortlisted firms soliciting a technical proposal. Shortlisted firms may be asked to attend meetings or participate in other discussions with KDOT regarding the project. Technical proposals will be evaluated on the basis of 1) the quality of the response to the RFP; 2) qualifications and experience of consultant personnel proposed for services; 3) proposed approach to performance of services; and 4) past performance history. In the event KDOT cannot reach agreement with the highest ranked firm, it will terminate negotiations with such firm and commence negotiations with the next highest ranked firm, and so on, until either agreement is reached for a satisfactory scope of services for a fair and reasonable price, or KDOT decides to pursue other alternatives. KDOT intends to conclude or terminate negotiations on or before September 20, 2019.

Notice Concerning Kansas/Federal Water Pollution Control Permits and Applications

In accordance with Kansas Administrative Regulations 28-16-57 through 63, 28-18-1 through 17, 28-18a-1 through 33, 28-16-150 through 154, 28-46-7, and the authority vested with the State by the administrator of the U.S. Environmental Protection Agency, various draft water pollution control documents (permits, notices to revoke and reissue, notices to terminate) have been prepared and/or permit applications have been received for discharges to waters of the United States and the state of Kansas for the class of discharges described below.

The proposed actions concerning the draft documents are based on staff review, applying the appropriate standards, regulations, and effluent limitations of the state of Kansas and the Environmental Protection Agency. Disabled parking is located on the north side of the Mills Building on either side of 9th Street. The north entrance to the Mills Building is accessible.

This regulation is proposed for adoption on a permanent basis. A summary of the proposed regulation and the economic impact follows:

Kansas Department of Revenue
Article 56. Ignition Interlock Devices

Amended K.A.R. 92-56-2. The proposed K.A.R. 92-56-2 is an amendment to an existing regulation that would require breath alcohol ignition interlock device manufacturers to include camera technology in all breath alcohol ignition interlock devices (BAIID) installed in the State of Kansas. New subsection (l) explains the image capture requirements for State approved devices. New subsection (m) corrects a citation defect in the existing regulation. New subsection (n) sets out a time frame for ignition interlock device manufacturers to comply with the new digital image capture requirements.

Economic Impact:

In discussions with the BAIID industry, the Department anticipates on average, an estimated impact of \$163.83 per individual. The increased cost is due to the addition of a camera requirement for all interlock devices. The estimated annual increase is \$738,467. Cost estimates are on the high end, as there is a likelihood that some of the BAIID providers will not have additional costs (the cameras are already incorporated into equipment) or pass them on to the consumer.

All interested parties will be given a reasonable opportunity to present their views, orally or

in writing, concerning the proposed regulations during the public hearing. In order to provide all parties with an opportunity to present their views, it may be necessary to request each participant limit any oral presentations to five minutes.

A summary of the proposed regulations and their economic impact follows:

K.A.R. 128-5-1. The Kansas Athletic Commission ("the Commission") seeks to amend this existing regulation to add language establishing bare-knuckle fighting, a form of professional boxing without gloves, as its own sanctioned sport, as opposed to merely a variation of one of the existing sports. Additionally, the Commission proposes amendments to eliminate redundant language covered explicitly within other subsections.

K.A.R. 128-6-8. This new regulation establishes procedures specifically for bare-knuckle fighting contests, including weight classifications, weigh-in procedures, attire and hand-wrapping restrictions, safety requirements, and general rules governing each contest.

Anticipated Economic Impact. The proposed regulations provide an opportunity for promoters to bring a new type of event to Kansas. The Commission believes that bare-knuckle fighting events will induce economic activity through event-related spending. The Commission estimates that each event will bring in around \$13,700, approximately 50 percent of which would go into the state general fund. In addition to the venues at which these events are held, professional sporting events directly impact several other areas of the economy including dining, retail shopping, lodging, and commercial transportation. Lastly, there are no anticipated costs associated that are expected to be incurred by or passed along to business, local governments, or members of the public with the addition and implementation of bare-knuckle fighting in Kansas.
