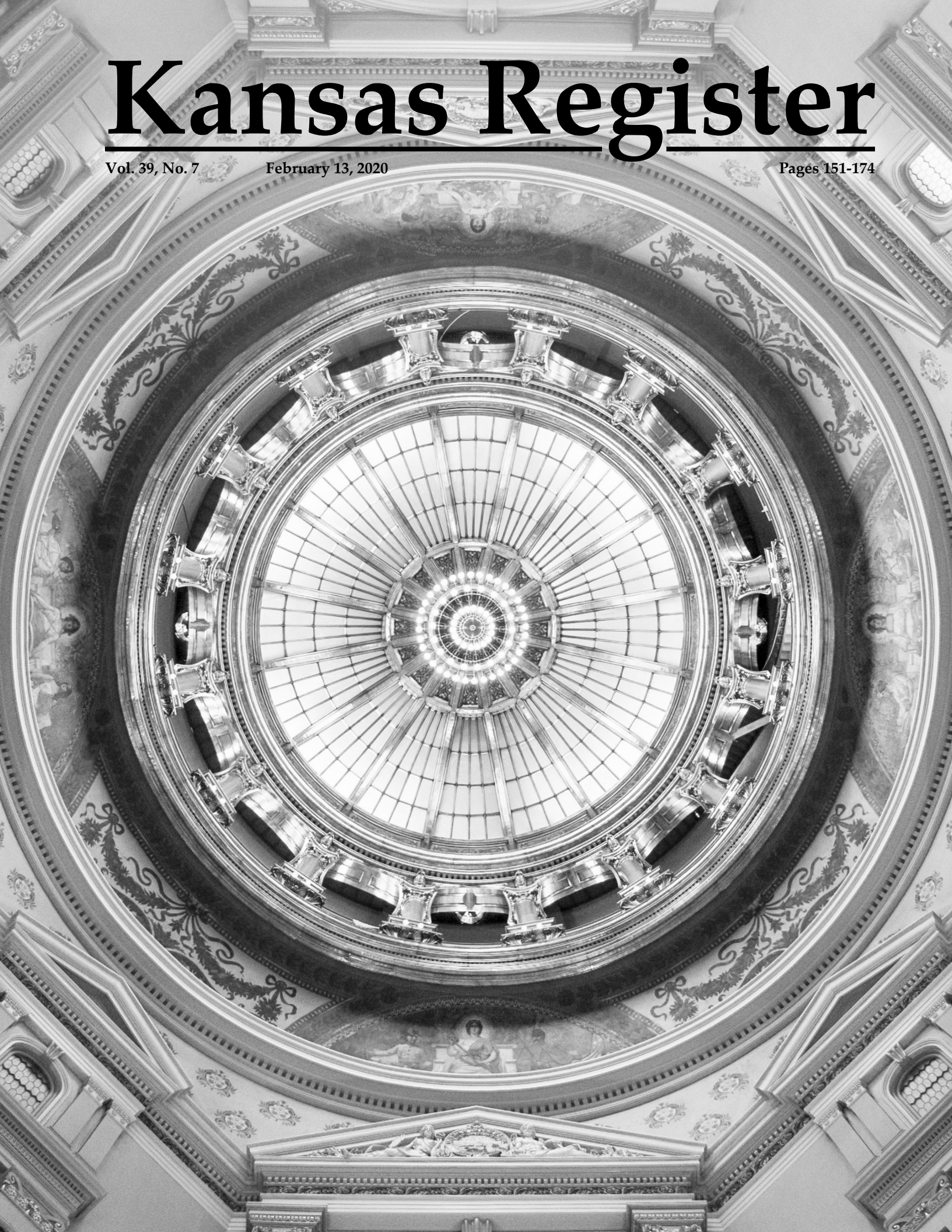

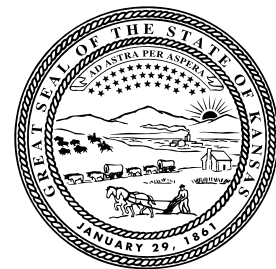

The Kansas Department of Transportation (KDOT) is seeking a consultant to provide construction inspection services for project 75-63 KA 2379-01. The project is located on U.S. 75 in Montgomery County from the Kansas/Oklahoma state line north to the south city limits of Caney.

**Schedule/Deadlines**

Request for Proposals (RFPs) are due on or before 12:00 p.m. (CST) February 21, 2020, to be delivered via email to [kdot.designcontracts@ks.gov](mailto:kdot.designcontracts@ks.gov). Evaluation and ranking of submissions will occur on or about February 28, 2020, after which time all firms that submitted will be notified of the ranking. Negotiations with the most highly ranked firm to commence on or about March 6, 2020. An agreement should be in place on or about March 16, 2020. The contractor should start on the project sometime around February – March 2020.

**Scope of Services to be Performed**

The inspectors must be capable inspecting any work on the project, which includes traffic control, HMA Paving, HMA Commercial Grade Plant operations, PCCP Paving/PCCP Plant operations, RC boxes, grading, RC bridges, pipes, subgrade, base, concrete, seeding, erosion control, inlets, fencing, signing, pavement marking, SWPPP inspections, CMS or AASHTOWare data entry, all project records, all project paperwork, and final paperwork, etc. Project records and paperwork including but not limited to: SWPPP inspections, diary, pay quantities, certifications, sample identifications, change orders, pay estimates, monitoring subcontractor payments, and monitoring contractor's payrolls, etc. Records and paperwork must be submitted accurately and timely. Anticipated staffing needs: provide one project inspector full time during construction seasons to work in conjunction with KDOT's project manager. The Kansas Department of Transportation (KDOT) is seeking qualified consulting firms prequalified in category 211 – Highway Design Major Facility or category 212 – Highway Design Minor Facility for the project listed below. #### Scope of Work

With the goal of establishing baselines for a system-wide performance-based practical design policy, the KDOT is seeking the services of a consulting engineering firm to evaluate KDOT's policies and practices for determining lane width and shoulder width on new and reconstruction highway projects. It is expected the analysis will include a thorough review of KDOT's current policies, review of policies of other states that have implemented Performance-Based Practical Design, and development of guidelines for KDOT that are based on factors that include, but are not limited to traffic volume, truck volume, speed, alignment, and route classification. Tools that may be used in performing the analysis include: Highway Safety Manual (HSM), Interactive Highway Safety Design Model (IHSDM), United States Road Assessment Program (usRAP), Roadside Safety Analysis Program (RSAP) or other similar analysis tools. The analysis would include applying the analytical tools to determine minimum values and guidance for lane and shoulder widths on non-interstate routes on the state highway system. In addition, the project will include the development of objective guidance on recommendations for maintenance of traffic (MOT) on state highway bridge replacement and repair projects. This guidance will consider the various approaches for handling traffic during construction and is to be based on a benefit/cost approach that considers factors such as user costs (time delay and adverse travel cost for both passenger cars and trucks), construction time, and construction cost estimates.

It is anticipated that this will be a multi-phase contract. These activities would be considered phase 1 with a target completion date of September 30, 2020. Additional phases, if added, would include similar analyses of other design elements incorporation into KDOT's performance-based practical design policies. Proficient abilities in such areas as highway geometric design, highway capacity analysis, and traffic analysis modeling are required.

#### Qualifications-Based Selection Process

**Article 78. Business Entities**

**100-78-1. Business entity certificate of authorization; expiration date.**

Each business entity certificate of authorization issued by the board shall expire on June 30 of each year, beginning June 30, 2021.

**100-78-2. Fees.**

The following fees shall be collected by the board:

- (a) Application for certificate of authorization ..... \$1,000.00
- (b) Annual renewal of certificate of authorization ..... \$1,000.00

The purpose of these new regulations is to implement the certification process described in K.S.A. 65-28,134. The regulations effectuate the legislature’s intent to expand the opportunities for employers to directly employ physicians to provide care to their employees and employees’ family members, and health insurers to directly employ physicians to provide care to their insured patients. Outside of those costs already incorporated in the legislation itself (fee for certificate), costs include routine state resource costs associated with promulgating these regulations. Although a qualified economist would be required to provide an expert opinion of the extent the regulations would impact economic growth, in the lay opinion of agency staff the regulations enhance business activities because the regulations implement a certification process that creates an additional mode of health-care delivery. (See economic impact statement approved by the Department of Budget).

**Article 15.—APPLICATION FOR PERMITS;  
DOMESTIC WATER SUPPLY**

**28-15-52. Interest rate.** (a) Each loan shall accrue interest for the entire life of the loan at a fixed rate set by the secretary. This fixed rate shall be calculated as spec-

ified in subsection (b). Fees for servicing the loans may also be set by the secretary.

(b) The interest rate shall be calculated as a percentage, as specified in the intended use plan, of three months’ average of the bond buyer’s weekly 20-bond GO (general obligation) index. The loan interest rate as calculated shall include any loan servicing fee.

(c) The interest rate and loan servicing fee may vary depending on the loan repayment period. (Authorized by K.S.A. 65-163f; implementing K.S.A. 65-163f and K.S.A. 2019 Supp. 65-163i; effective Oct. 10, 1997; amended Feb. 28, 2020.)

**28-15-53. Repayment of loans.** (a) All principal and interest shall be repaid in accordance with the terms of the loan agreement. Repayments shall begin no later than one year following project completion. Repayment of the loan shall not exceed a 30-year repayment period, except for a loan to a disadvantaged community. Any loan to a disadvantaged community may exceed a 30-year repayment period if both of the following conditions are met:

(1) Repayment of the loan does not exceed a 40-year repayment period.

(2) The repayment period does not exceed the expected design life of the project.

(b) Prepayment of the principal in whole or part may be made, in accordance with the terms of the loan agreement. (Authorized by K.S.A. 65-163f; implementing K.S.A. 65-163f and K.S.A. 2019 Supp. 65-163i; effective Oct. 10, 1997; amended Feb. 28, 2020.)
